




#### Vision



#### Jo Ann Brandon, LMSW-ACP

Jo Ann Brandon is the Clinical Supervisor of the Austin Travis County Mental Health Mental Retardation Center's C.A.R.E. Program. She also has a private psychotherapy practice.

As clinical supervisor, Ms. Brandon provides individual, couple and group psychotherapy; consults and prepares families for adoption; and develops and implements treatment interventions.




